

# Fall 2017 Important Dates

Fee payment/Confirmation deadline for PRE-REGISTERED students. Bills will not be mailed and will be available through your myTSU account beginning **July 13, 2017**. *Class schedules will be deleted if fees are not paid (or students must **confirm** registration if their fees will be covered by scholarships, authorized deferments and/or financial aid) by 4:30 p.m. at the Cashier Window or by 6:00 p.m. on myTSU (**online payments only**). *Students may re-register during the regular registration period.**

**August 18, 2017**

(Students who registered April 3, 2017 – August 18, 2017)

Fee payment/ Confirmation deadline for students who registered **August 21 -25, 2017**. (Late - \$100 fee)

All fees must be paid in full on **September 1, 2017 (or students must **confirm** registration if their fees will be covered by scholarships, authorized deferments and/or financial aid) by 4:30 p.m. at the Cashier Window or by 6:00 p.m. on myTSU (**online payments only**).**

Early Registration for TBR, UT, State and TSU employees.

**July 24, 2017 – August 18, 2017**

NOTE: Fee Waiver Forms will not be processed for students who register prior to **July 24, 2017**. *Class schedules will be deleted if fees are not paid (or students must **confirm** registration if their fees will be covered by scholarships, authorized deferments and/or financial aid) by **4:30 p.m. on August 18, 2017**.*

Therefore, in some instances, a refund may not be applicable. Students are encouraged to better plan their schedules and retain their full-time status on their way to a timely and successful graduation.</p> <p>Students dropping and adding a class on or after the first day of classes (August 21, 2017), must process both the Add and the Drop ON THE SAME DAY and the Add must be processed first.</p>	<b>August 20, 2017* – Fall Term</b>
Last day to withdraw from all classes or drop classes and obtain a <b>75%</b> refund of registration fees.	<b>September 3, 2017*</b>
Last day to withdraw from all classes or drop classes and obtain a <b>25%</b> refund of registration fees.	<b>September 16*</b> (No refunds will be made after this date.) *Date falls on a Saturday or Sunday.
<p><b>TN eCampus</b> courses <b>cannot</b> be evenly exchanged with TSU courses when students drop/add on or after the first day of classes (August 28, 2017). <p><b>R A2 TN eCampus Accelerated Term</b> (Seven-Weeks) Fee Adjustment Deadline for Dropped Courses</p>	<p><b>October 17, 2017 - 100%</b> <b>October 21, 2017* - 75%</b> <b>November 1, 2017 - 25%</b> (No refunds will be made after this date.) *Date falls on a Saturday.</p>
<p><a href="#">Financial Aid Refunds</a></p> <p>Refunds will be available for students who have registered, completed all paperwork in the Financial Aid Office, confirmed that they will be attending for the term on myTSU, and have actual aid credited to their accounts. <b>All students are required to sign up for direct deposit. Direct Deposits may take up to three business days to post to bank accounts. Students who do not sign up will receive their refunds via checks mailed to their permanent addresses on file, beginning September 25, 2017.</b> To sign up, log on to myTSU and select <i>Student</i>, then <i>Refund Account Information</i>.</p>	<p>Beginning <b>September 8, 2017</b></p> <p>Direct deposits may take up to three business days to post to bank accounts.</p>
