Bills will not be mailed and will be available through your myTSU account beginning <b>July 15, 2019</b>. <i>(Class schedules will be deleted if fees are not paid or students must <b>confirm</b> registration if their fees will be covered by scholarships, authorized deferments and/or financial aid by 4:30 p.m. at Cashier Window or by 6:00 p.m. on myTSU, <b>online payments only</b>). <p>Last day to submit discount forms for spouses/dependents of TBR/UT employees and dependents of TN public school teachers.</p>	<p><b>September 9, 2019</b></p>

<p>Last day to withdraw from all classes or drop classes and obtain a <b>100%</b> refund of liable credit hours.</p> <p>Note: Refunds are calculated based on liable credit hours. Therefore, in some instances, a refund may not be applicable. Students are encouraged to better plan their schedules and retain their full-time status on their way to a timely and successful graduation.</p> <p>Students dropping and adding a class on or after the first day of classes (August 19, 2019), must process both the Add and the Drop <b>ON THE SAME DAY</b> and the Add must be processed first.</p>	<p><b>August 18, 2019* – Fall Term</b></p>
<p>Last day to withdraw from all classes or drop classes and obtain a <b>75%</b> refund of registration fees.</p>	<p><b>September 1, 2019*</b></p>
