	the things you are concerned about, if you have issues in spirit of shared governance,

	Updates: Received approval for 6 new tenure-track faculty positions, Deans have been	
	surveyed about vacant positions, strategic plan and fall 2023 workloads.	
	Underfunding: In the questions to drive the discussion, regarding "underfunding" what are you referring to? Local or university level?	
	CG – This have been lots of complaints over the years (not with the current leadership)	
	when I was reviewing previous committee minutes, these are entrenched issues that	
	have gone unanswered and compiling data would give us power to have	
	recommendations heard, and this is around restorative practices. We want to get data	
	to present that won't fall on deaf ears. I can send you them for feedback for them as	
	they are following a model of restorative processes. I added the term underfunding to	
	identify the problem, coping mechanisms of where issues are and how faculty have	
	been impacted over the years, to allow space for a voice. "Underfunding" is referring	
	to the chronic underfunding to HBCUs.	
	AYS – This is a great time to advocate to sit and talk to you, workings and charge of the	
	committee. We haven't reviewed and revamped this committee, working since the fall	
	on the issues presented then.

	us in the opposite direction than R2-R1. Right now, if you are publishing now, it is		
	coming out of pocket. RSP needs to have discussion with how much money they really		
	have and how those funds are going to be used for faculty publishing and where is the		
	money coming from.		
	AYS – In the chat question if we can add publishing costs to the budget? Maybe we can		
	add this as a budget line item for a high publishing department in their budget, may		
	not be funded but worth an ask. You can include publishing fees in grant proposals as		
	well.

	Senator Pleban (FP) - Asking your department to pay publishing or add to department		
	budgets, historically budgets have been cut over the years not added, especially with

Cyber incident:

Tim Warren: intruder got in on Citrix that we were decommissioning. They got a student login, we immediately shut down internet. When they got in, they got to 16 PCs and dumped the content of PCs. We now have an external consultant looking at the contents of the information. We reopened everything Wednesday and changed everyone's login to 16-character login. Those who information was copied have been informed. We are using them for 24/7 monitoring, we are doing deep dive scanning in the evening hours for all computers. New Citrix has new setup information. Multifactorial identification has been implemented everywhere.

AYS – Can you speak on how the university is set up compared to how it was set up when you started at TSU? Are we all under one umbrella now?

Tim Warren – Now we have a nice network core and nice firewalls, the campus is segregated into cyberlands that are segmented out that helps to isolate threats to smaller area.

RA – Multifactor authentication – Are elevated accounts impacted in that as well? **Tim Warren** – Yes, you may need to set up it though. (Reviewed process to reset password)

TR – Was this threat local or international?

Tim Warren – It was international, but we don't have a specific location. Encryption is the big key mostly, selling data was the main point of this attacker.

Senator Fasoro – Is Citrix back online?

Tim Warren – Yes but you need to use the light version for right now, replacing phone system to cloud based solution.

CB – Some student still cannot get in or is not having all the functionality, will this be coming back?

Tim Warren – I will check into that, they may not have gotten to that yet, the light version does not have all the features of the client version.

AYS – Can you speak on the security courses that faculty need to do?

Tim Warren – Right now they are not required, but we need to change this.

WJ – We want to thank Tim at how fast this response was.

Faculty Trustee Report:

WJ – Good news, budget 5.5% raise plus 3% performance for faculty. We raised housing cost 2.41%, this covers the cost of new buildings, debt service, and give \$430,000 revenue, (\$200,000 for maintenance). The enrollment for Fall was \$17 million in tuition profit, all hotel costs covered with profit only, didn't use anything from plant fund. We are looking at a profit for this academic year (\$97 million, budgeted \$99 million, \$1.2 from this summer), owed \$19 million from the state. We put in some financial restrictions, any changes in the budget over 10% on any line item requires board approval. We are looking at a restructure of the university, COO, engineer, etc. We are moving forward and took control of the university today. RM you have been put on the subcommittee; hope you can make the meeting.

AYS – Can you touch on agreements that we have been put in place for the reports we have to give and the timeline to give?

WJ – There are 12 resolutions, several by state legislator, we agreed to some but not all. We used their requests to define the terms, outline a template for data for us to gather beyond what they asked for, (and used it as a template of information we can

gather better information on what we do) and those entities are to be submitted to the board every 2 weeks, to THEC and state Legislature and Building Commission.

WJ – There was a perception that the president was informing the board and we accept their word, that has changed completely. I feel good about where we are at.

AYS – The meeting today felt like an accountability meeting, perception before did not seem like it did today.

WJ – Pam Martin and Steve Corbio were reappointed, first term was staggered, reappointment was for a second term is a 6-year term.
