# PROFESSIONAL LICENSURE

Students completing programs in the College of Health Sciences are eligible to take the licensing or certification exams listed below for their respective programs of study. However, successfully passing a licensing or certification exam may only be one of the requirements for unencumbered practice. Since each state and territory defines its own requirements for licensure, certification, and practice, students need to inquire with the appropriate licensing board or certification body about additional state-specific requirements such as background checks, years of professional experience, jurisprudence exams, etc. The College of Health Sciences provides the following information for current and prospective students interested in health programs that may require professional licensure to practice.
