II. Gathering Information

Before you start doing in-depth research on your topic, you will need to gather some background information in order to be able to focus on a theme and outline effectively. While using your background information, be sure to take notes concerning relevant issues within your topic; differing issues and definitions of key concepts and ideas. Appropriate sources for locating background information would include encyclopedias, dictionaries, almanacs, yearbooks, handbooks, and bibliographies. In order to find information concerning **Nursing Care** and **Cancer Patients**, you will need to look for background material in **nursing** and **cancer**. You may locate these resources by:

- Searching the Library's online catalog under for general encyclopedias underneath the subject heading *Encyclopedias* and *Dictionaries*. From the entries retrieved, choose the ones which would be relevant to your topic.
- **2.** Take notes of the appropriate classification numbers for specific resources in your subject area and locate them in the appropriate reference section.
- **3.** You may refine your search by using the keyword search button and combining words in general such as cancer and nursing with words such as encyclopedia, dictionary, etc.
