<p>Fee payment/Confirmation deadline for PRE-REGISTERED students. Bills will not be mailed and will be available through your myTSU account beginning <b>July 13, 2015</b>. <i>(Class schedules will be deleted if fees are not paid</i> or students must <i>confirm</i> registration if their fees will be covered by scholarships, authorized deferments and/or financial aid by 4:30 p.m. at Cashier Window or by 6:00 p.m. on myTSU, <b>online payments only</b>). <i>Students may re-register during the regular registration period.)</i></p> <p>See <a href="#">Financing Your TSU Education</a> for payment options.</p>	<p><b>August 21, 2015</b></p> <p>(Students who registered April 6, 2015 – August 21, 2015)</p>
<p>Fee payment/ Confirmation deadline for students who registered <b>August 24-28, 2015</b>. (Late - \$100 fee)</p>	<p>All fees must be paid in full on <b>August 31, 2015</b> (or students must <i>confirm</i> registration if their fees will be covered by scholarships, authorized deferments and/or financial aid) by 4:30 p.m. at Cashier Window or by 6:00 p.m. on myTSU, <b>online payments only</b>).</p>
<p>Early Registration for TBR, UT, State and TSU employees.</p>	<p><b>July 27, 2015 – August 28, 2015</b></p> <p>NOTE: Fee Waiver Forms will not be processed for students who register prior to <b>July 27, 2015</b>. <i>(Class schedules will be deleted if fees are not paid</i> or students must <i>confirm</i> registration if their fees will be covered by scholarships, authorized deferments and/or financial aid by <b>4:30 p.m. on August 21, 2015</b>)</p>
<p>Regular Registration for TBR, UT, State and TSU employees. No Late Registration fee is assessed for these groups</p>	<p><b>August 24-28, 2015</b></p>

First day of classes.	<b>August 24, 2015</b>
<p>Last day to withdraw from all classes or drop classes and obtain a <b>100%</b> refund of liable credit hours.</p> <p>Note: Refunds are calculated based on liable credit hours. Therefore, in some instances, a refund may not be applicable. Students are encouraged to better plan their schedules and retain their full-time status on their way to a timely and successful graduation.</p> <p>Students dropping and adding a class on or after the first day of classes (August 24, 2015), must process both the Add and the Drop ON THE SAME DAY and the Add must be processed first.</p> <p>RODP courses <b>cannot</b> be evenly exchanged with TSU courses when students drop/add on or after the first day of classes (August 24, 2015). RODP classes can be identified by section number <b>R50</b>.</p> <p>RODP courses are charged <b>separately</b> from TSU courses.</p>	<p><b>August 23, 2015*</b></p> <p>*Date falls on a Sunday.</p>

<p>R A2 RODP Accelerated Term (Seven-Weeks)</p> <p>Fee Adjustment Deadline for Dropped Courses</p>	<p><b>October 18, 2015* - 100%</b></p> <p><b>October 25, 2015* - 75%</b></p> <p><b>October 31, 2015* - 25%</b> (No refunds will be made after this date.) *Date falls on a Saturday or Sunday.</p>
<p>Last day to submit discount forms for spouses/dependents of TBR/UT employees and dependents of TN public school teachers</p>	<p><b>September 6, 2015*</b> *Date falls on a Sunday.</p>
<p><a href="#">Financial Aid Refunds</a> disbursed.</p> <p>Refunds will be available on student ID cards for students who have registered, completed all paperwork in the Financial Aid Office, confirmed that they will be attending for the term on myTSU, and have actual aid credited to their accounts. Refunds will appear on the ID card (comdata account), within a 24 to 48 hour period from the date of the refund transaction that appears on your student account for the Fall term. <b>Direct deposit is required if you are a freshman, transfer, or a returning student with a new ID card. Direct Deposits may take up to three business days to post to bank account. Students who do not sign up will receive their refunds via checks mailed to their permanent addresses on file, beginning September 23, 2015.</b> To sign up, log on to myTSU and select <i>Student</i>, then <i>Refund Account Information</i>.</p>	<p>Beginning <b>August 21, 2015</b> (after 9:00 p.m. for comdata accounts) Direct deposits may take up to three business days to post to bank account.</p>
