<p>Fee payment/Confirmation deadline for PRE-REGISTERED students. Bills will not be mailed, but will be available through your myTSU account beginning <b>July 16, 2018</b>. <i>(Class schedules will be deleted if fees are not paid or students must <b>confirm</b> registration if their fees will be covered by scholarships, authorized deferments and/or financial aid by 4:30 p.m. at Cashier Window or by 6:00 p.m. on myTSU, <b>online payments only</b>). (Late - \$100 fee)</p>	<p>All fees must be paid in full on <b>August 31, 2018 (or students must <b>confirm</b> registration if their fees will be covered by scholarships, authorized deferments and/or financial aid) by 4:30 p.m. at Cashier Window or by 6:00 p.m. on myTSU, <b>online payments only</b>).</b></p>
<p>Early Registration for TBR, UT, State and TSU employees.</p>	<p><b>July 23, 2018 – August 17, 2018</b></p> <p>NOTE: Fee Waiver Forms will not be processed for students who register prior to <b>July 23, 2018</b>. <i>(Class schedules will be deleted if fees are not paid or students must <b>confirm</b> registration if their fees will be covered by scholarships, authorized deferments and/or financial aid by <b>4:30 p.m. on August 17, 2018</b>)</i></p>

Last day to submit discount forms for spouses/dependents of TBR/UT employees and dependents of TN public school teachers.	<b>August 31, 2018</b>

<p>Last day to withdraw from all classes or drop classes and obtain a <b>100%</b> refund of liable credit hours.</p> <p>Note: Refunds are calculated based on liable credit hours. Therefore, in some instances, a refund may not be applicable. Students are encouraged to better plan their schedules and retain their full-time status on their way to a timely and successful graduation.</p> <p>Students dropping and adding a class on or after the first day of classes (August 20, 2018), must process both the Add and the Drop ON THE SAME DAY and the Add must be processed first.</p>	<b>August 19, 2018* – Fall Term</b>
Last day to withdraw from all classes or drop classes and obtain a <b>75%</b> refund of registration fees.	<b>September 2, 2018*</b>
Last day to withdraw from all classes or drop classes and obtain a <b>25%</b> refund of registration fees.	<b>September 15, 2018*</b> (No refunds will be made after this date.) *Date falls on a Saturday or Sunday.
<p><b>TN eCampus</b> courses <b>cannot</b> be evenly exchanged with TSU courses when students drop/add on or after the first day of classes (August 27, 2018). <b>R A2 TN eCampus Accelerated Term</b> (Seven-Weeks)  Fee Adjustment Deadline for Dropped Courses	<b>October 16, 2018 - 100%</b>  <b>October 20, 2018* - 75%</b>  <b>October 31, 2018 - 25%</b>  (No refunds will be made after this date.)  *Date falls on a Saturday.
<a href="#">Financial Aid Refunds</a>  Refunds will be available for students who have registered, completed all paperwork in the Financial Aid Office, confirmed that they will be attending for the term on myTSU, and have actual aid credited to their accounts. All students are required to sign up for direct deposit. Direct Deposits may take up to three business days to post to bank account. Students who do not sign up will receive their refunds via checks mailed to their permanent addresses on file, beginning September 24, 2018. To sign up, log on to myTSU and select <i>Student</i> , then <i>Refund Account Information</i> .	Beginning <b>September 7, 2018</b>  Direct deposits may take up to three business days to post to bank account.
