Students completing the Teacher Education Program in Early Childhood or one of the content areas (English, mathematics, biology, etc.) are eligible for licensure to teach in the state of Tennessee. Likewise, students completing programs in Instructional Leadership, or Professional School Counseling are eligible for licensure to practice in the state of Tennessee. Although successful program completion in Teacher Education, Instructional Leadership, or Professional School Counseling enables candidates to be recommended for licensure in Tennessee, other states vary in licensure/certification requirements. Therefore, individuals interested in teaching or practicing outside of Tennessee will need to investigate state-specific requirements. Current or prospective students with questions about licensure/certification should contact Teacher Education and Student Services (Teacher Certification@tnstate.edu) in the College of Education.

To assist individuals interested in teaching/practicing in other states or the United States territories, the College of Education has listed resource websites (see below) that provide information about licensure/certification requirements specific to each state or territory.
